Request for Official Information

On 21 September 2020, the Ministry for Pacific Peoples (the Ministry) received, under the Official Information Act 1982 (the Act), a request from s 9(2)(a), on behalf of Palmerston North City Council, for the following information:

- *The total amount of all MPP related funding that has been allocated towards Palmerston North in comparison to other cities in New Zealand over the last 5 years, and high-level information on what this funding has been for and when it has been allocated/provided.*
- *The total amount of all MPP related funding that has been allocated towards the Manawatu-Wanganui region in comparison to other regions in New Zealand over the last 5 years, and information on what this funding has been for, and when it has been allocated/provided.*

In response to your request, please find enclosed the following eight tables showing the total amount allocated in the last five years for each of the Ministry's funding programmes, broken down by city and region. For further context, the Ministry has also included the number of applications received and approved.

Tables one and two, outlined below, are in relation to the Languages Innovation Fund (LIF)/Community Languages Fund (CLF):

- Table One: Number of LIF/CLF applications received and approved, and the total amount allocated for each financial year from 2019/20 to current (up to 21 September 2020), broken down by city.
- Table Two: Number of LIF/CLF applications received and approved, and the total amount allocated for each financial year from 2019/20 to current (up to 21 September 2020), broken down by region.

Tables three and four, outlined below, are in relation to the Pacific Language Weeks Series (PLWS):

Please note, some of the Ministry's funding programmes have not been running over the entire date range you have specified in your request as they are newly established initiatives.

The Ministry's Provider Languages Fund (PLF) also falls in scope of your request, however, please note that the Ministry is unable to provide a breakdown of the amount allocated for this funding programme as applications are currently in the assessment phase of the process. Therefore, no funds have been allocated for the PLF.

Furthermore, with regard to the Toloa Programme funding, please note that applications for 2020/21 are also currently in the assessment stage of the process, and therefore, no funds have been allocated during this financial year.

As such, these aspects of your request are refused under 18(e) of the Act, as the information does not exist.

In the spirit of being helpful, further information about each of the Ministry's funding programmes, mentioned above, are provided in turn below.

Pacific Languages

The Ministry is aware of the increasing concern around the retention of Pacific languages both in Aotearoa and abroad. It recognises that language is important for Pacific peoples' cultural identity, sense of belonging, and their potential to participate with confidence in society. These are essential to the health, well-being, and the long-time success of Pacific peoples.

To address the notable decline in the number of Pacific language speakers, including Pacific language proficiency, the Ministry leads and administers the three funding initiatives provided overleaf.

Languages Innovation/Community Languages Fund

The LIF was launched on 26 November 2019. This was in response to community feedback during the Ministry's Pacific Aotearoa engagements with over 2,500 Pacific peoples in 2018.

In June 2020, LIF was replaced by the CLF. This was to show and reiterate the Ministry's community focus and strong support of grassroots community and family language projects. Applicants can apply for up to \$10,000 in funding depending on the scope and scale of their language initiative.

The CLF prioritises initiatives that:

- are targeted towards Pacific community groups and Pacific families
- share and pass on Pacific language knowledge
- enables accessibility to language learning
- increases the awareness and value of Pacific languages in Aotearoa
- helps increase and grow the number of speakers of Pacific languages.

Provider Languages Fund

The PLF was launched on 1 August 2020 at the Cook Islands Language Week launch. Applicants were eligible to submit proposals for up to \$50,000.

The purpose of the PLF is to support established Pacific providers who deliver a range of Pacific language initiatives that will help revitalise, maintain, and increase the number of speakers of Pacific languages to strengthen their identities and cultural confidence.

Pacific Language Weeks Series

The PLWS is a major part of the Ministry's commitment to the revitalisation of Pacific languages. The purpose of the PLWS is to recognise, value, and celebrate the heritage languages of the various Pacific nations in Aotearoa.

The Ministry has supported and delivered the PLWS since 2009. It works closely with, and provides funding to, Pacific communities to support the promotion and maintenance of the languages regarding the nine main Pacific groups in New Zealand: Rotuma, Samoa, Kiribati, Cook Islands, Tonga, Tuvalu, Fiji, Niue, and Tokelau. The Toloa Programme

The Ministry supports the aspirations of Pacific communities to grow in areas of work that are future focused and intentional. This involves supporting Pacific peoples to enter sectors where the potential to earn a higher income exists as employees, entrepreneurs, and business owners.

The Pacific peoples' population in New Zealand is young and is projected to increase rapidly with over a third of Pacific peoples (105,516) aged between 0-14 years. This demographic represents the future workforce.

In addition to this, the 2013 census indicated that, at 2 per cent, Pacific employees have the lowest representation in the Science, Technology, Engineering and Mathematics (STEM) sector compared to other ethnic groups such as, Māori, Asian and European/Pākehā etc.

These statistics presented the Ministry with an opportunity to develop Government initiatives to establish a pipeline for, and increase, Pacific participation into the growing STEM industry. This will provide a real pathway for Pacific peoples to achieve their aspirations and contribute to the New Zealand economy.

In 2015, the Ministry developed Toloa as a pilot with the intent to explore initiatives with a longer-term aim for Pacific young people to participate in the STEM sector from early childhood through to postgraduate study and entry into the workforce. Toloa is the only programme funded by Government which offers a scaffolded STEM focus.

The following Toloa initiatives were successfully piloted between 2015 and 2019:

Toloa Community Fund

The Toloa Community Fund was established to support organisations and community groups to promote and deliver STEM activities to Pacific young people and communities. The following three categories of funding are available for applicants to apply for to assist with delivering STEM related activities:

1. Grassroots initiatives – grants up to \$5,000
2. Emerging initiatives – grants up to \$20,000
3. Collaboration initiatives – grants up to \$50,000

Toloa Kenese Fund

The Toloa Kenese Fund was set up to support STEM providers to deliver local, regional, and national initiatives that lifts STEM aspirations amongst Pacific Communities within primary, intermediate, and secondary school target audiences. STEM providers can apply for grants up to \$50,000 per annum.

Toloa Tertiary Scholarships

The Toloa Tertiary Scholarships are funded by the Ministry to support and encourage Pacific students to pursue STEM subjects at tertiary level with the aim to increase the level and number of Pacific people employed in STEM careers.

Pacific Aotearoa Community COVID-19 Fund

The Ministry acknowledges the importance around ensuring that communities are able to lead their own solutions. With the appropriate support, they may not only achieve the vision and goals set out in Lalanga Fou, but also to respond to, and recover from, the impacts of the COVID-19 pandemic.

The CCF is a new initiative that aims to provide investment into the 'informal, unpaid or volunteer' Pacific economy. This funding enables Pacific communities to drive their own COVID-19 recovery strategies, initiatives, and actions. It is made up of the following three funding categories:

1. Grassroots initiatives – Grants up to \$5,000
2. Acceleration initiatives – Grants up to \$10,000
3. Lift-off initiatives – Grants up to \$50,000

The CCF was officially opened to the public on 27 July 2020. Originally only live for two weeks, the opening period for the CCF was extended until 28 August 2020.

The Ministry works with all applicant groups going forward, including those which were declined. Unsuccessful applicants were supported to have their submissions considered by other government agencies, such as the Ministry of Social Development. The Ministry for Pacific Peoples will continue to work with community groups to increase their abilities around producing strong funding applications.
