Give us your feedback on the Ministry's Long-term Insights Briefing

The Ministry for Pacific Peoples is the voice of Pacific peoples in government – and our voice comes from our Pacific communities. Our role is to improve Pacific outcomes by working alongside our communities to achieve their vision of a thriving, resilient and prosperous Pacific Aotearoa. We do this by building relationships, knowledge and expertise to better connect Pacific peoples and government.

The Long-term Insights Briefings (LTIB) are a new government requirement under the Public Service Act 2020. They require agencies and government departments to think at least 10-years ahead, examining future trends, risks and opportunities that could affect Aotearoa New Zealand. LTIBs help promote long-term thinking so that the public service is better placed to respond to future change and can deliver enduring benefits for people in Aotearoa. The topic we are proposing to consider is – **Improving Pacific data equity: Opportunities to enhance the future of Pacific wellbeing**. The LTIB will enable a deeper understanding about Pacific data equity to help inform future decisions and policy options for Pacific peoples.

Under legislation we are required to undertake two rounds of public consultation to ensure our final LTIB reflects public views – the first on the proposed topic, and the second on the detailed LTIB content.

We are seeking written and verbal feedback on our proposed LTIB topic. We have developed a consultation document, which can be completed on our [website](#). This document is for our first round of public consultation. It provides you with key information to help with your feedback, including the following questions:

1. What do you think of the proposed definitions for Pacific data and Pacific data equity?
2. What does Pacific data and Pacific data equity mean to you?
3. Does what you hear about Pacific statistics/data in Aotearoa reflect your community?
4. How could Pacific data better support Pacific communities?
5. What do you think are the greatest opportunities or risks for Pacific data equity?
6. Do you agree that Pacific data equity is a key enabler for Pacific wellbeing? Why?
7. What are your aspirations for Pacific data now and in the future?
8. What other issues or topics would you like the Ministry to explore in future LTIBs?
9. Do you have any further comments you would like to share?
